COMMUNIQUE ISSUED AT THE END OF A 4-DAY TRANS AFRICA INVESTMENT SUMMIT 2022, ORGANISED BY PILOT INTERNATIONAL. WOMEN ECONOMIC FORUM, HELD AT HOTEL TRIANGLE, PLOT 16 BUGANDA ROAD, KAMPALA FROM 26-29 OCTOBER 2022, KAMPALA UGANDA, WITH THE THEME: EXPLORING INVESTMENT OPPORTUNITIES IN AFRICA

OVERVIEW

The Trans Africa Investment Summit 2022, the first of its kind was organized to enchant women entrepreneurs with investment opportunities across Africa through exhibitions of their products, presentations and discussions, information sharing, networking, and the like. The summit was physically attended by 51 from Burundi, Kenya, Nigeria, Cameroun, Zimbabwe, and Uganda; and 40 virtually from across the globe including Australia, DRC, Rwanda, South Africa, Sweden, U.A.E, the UK, and the USA.

It was opened by the Rt Hon 2^{nd} Deputy Prime Minister of the Republic of Uganda and Minister of East African Community and addressed by, among others State Minister for Trade and Industry, Republic of Uganda. A total of 33 presentations were made.

The summit was characterized by rich presentations and Case studies on aspects such as;


- Human security peace and sustainable development;

Expensive and cumbersome intra-Africa entry/ travel/ trade/communication I. requirements

Lack of a physical networking platform for interfacing and negotiating with their II. potential clients and partners to facilitate trade amongst African countries and the world

Poor mechanism to directly link buyers and sellers within Africa and the Diaspora III.

RECOMMENDATION

Aware that the current 1.4 billion African population constituting 18.2% of the world population will in the next 30 years grow to 26.3% (2.5 billion),

Cognisant of numerous regional economies across Africa with a potential single economic bloc valued at \$3.4-trillion.

Fully aware that The African Continental Free Trade Area (AfCFTA)i officially came into effect in July 2019, and has been signed by 98.18% of African countries whose aim is to create a single market for goods and services, as well as a customs union that facilitates the movement of people (using a single passport for countries in the AU), money and goods across the continent,

Encouraged that as of October 2022, 44 of the 54 signatories (81.5%) have deposited their instruments of AfCFTA ratificationii

At the end of the 4 days, the delegates of the Trans Africa Investment Summit 2022, implore the Chairman of AU and all members to expedite the ratification of AfCFTA and its attendant benefits that will spur homegrown and sustainable investment models.
